Campbell Colloquium, May 2009: Oslo Report

- The Campbell Methods Coordinating Group held a very lively open meeting, with a productive discussion around systematic review methods for reviews addressing social welfare, crime and justice, and education. One of the major discussions revolved around the potential adoption of the Cochrane Handbook as a guiding policy document for the Campbell Collaboration. - Mark Petticrew led a symposium on subgroup analyses, in which speakers de-


scribed their experiences conducting subgroup analyses in systematic reviews, and the difficulties—both statistical and theoretical—they encountered. A manuscript on the Field's work on subgroup analyses has been submitted for publication.

- A workshop on the Field's collaboration with the WHO Measurement, Evidence and Knowledge Network (MEKN) was led by Peter Tugwell. The group discussed methods of addressing equity and the social determinants of health in systematic reviews; we debated a series of recommendations proposed



by the Field.

- Vivian Welch gave an oral presentation on her Cochrane Methodology Review, described on page 6.
- An Open Equity Meeting was held, with participants from Australia, Canada, Belgium, the US, and Bangladesh; we welcomed Dr. Faye Taxman of the International Network for Justice Health (based at George Mason University in the US) to the Equity Field.

Equity-Oriented Toolkit for HTA: Next Steps

The WHO Collaborating Centre for Knowledge Translation and Health Technology Assessment in Health Equity, housed at the Centre for Global Health at the University of Ottawa, is currently in the process of updating and expanding its Equity-Oriented Toolkit for Health Technology Assessment (HTA). The Equity-Oriented Toolkit is based on a needs-based model of health technology assessment. It provides tools that explicitly consider health equity at each of the four steps of health technology assessment: 1) Burden of Illness, 2) Community Effectiveness, 3) Economic Evaluation, 4) Knowledge Translation and Implementation.

The Centre has recently received seed funding from the Canadian

Institutes of Health Research to update the toolkit via a series of workshops targeting both academics and policy makers. This will allow a debate on the tools to be included – or not – at each step. Additionally, the Centre is exploring the plausibility of incorporating health impact assessment within the Toolkit.

The Toolkit will be featured in two presentations at the upcoming Canadian Conference on International Health taking place October 25th- 28th in Ottawa, Canada.



Next Generation Priority Setting in Healthcare: A Call Out to Study Participants!

As we all know, healthcare is a field with limited resources and challenges with respect to setting priorities. Alejandra Jaramillo, a student in the MSc in Health Systems Program at the University of Ottawa, is going to be researching this particular issue and will be developing a next generation priority setting tool that can be applied by healthcare organizations and stakeholders in order to effectively launch initiatives and allocate resources.

The research effort will be incorporating the use of “health equity” and the “social determinants of health”, which has been identified as a current criteria gap in health research for systematic reviews. This improved method will build upon existing frameworks and lead to more transparent, fair and equitable decisions with respect to research priorities.

The research methodology involves a comparative analysis of priority setting approaches as well as expert consultations in order to identify new decision factors and processes that can be incorporated into the next generation methodology. Once finalized, the new tool will be piloted with the Cochrane Musculoskeletal Group using the condition of Osteoarthritis (OA) to set priorities.

In order to build an effective priority setting tool, a minimum of 60 stakeholders representing different groups will be engaged: decision-makers, policy-makers, researchers, clinicians, patients, and consumers located globally.


