## Canadian-Croatian GAP program to overcome health gaps



# Linking Equity Methods Research and Global Indigenous Health Research: towards the creation of a resource group

Within Canada and abroad, two branches of health research are motivated by the challenge of enabling more equitable health outcomes worldwide: Global Indigenous Health Research and Equity Methods Research. While both fields are relatively new and both work to inform and promote the health of disadvantaged people worldwide, global indigenous health researchers and equity methodologists often labour independently, without referring to each other. To remedy this, the Canadian Coalition for Global Health Research and partners, with generous support from the Canadian Institutes of Health Research, are preparing for a project titled “Linking Equity Methods Research and Global Indigenous Health Research: towards the creation of

a resource group” to explore potential syntheses between the two fields of research. In preparation for a meeting later this spring, a research methods inventory and environmental scan are being undertaken in advance to support the discussions.

research methods inventory or environmental scan.

## New Review on Parental Consent in Studies Targeting Children

A team of researchers in Australia is currently developing a protocol for a systematic review registered with the Cochrane Methodology Review Group titled “Active versus passive parental consent for improving participant recruitment and outcomes in studies targeting children”. The review aims to describe and assess the effects of using active (opt-in) versus

passive (opt-out) parental consent on participant recruitment and outcomes in studies targeting children. Doing so will provide much needed information regarding the extent to which a systematic bias in sample characteristics and/or study outcomes may result from active or passive parental consent procedures. This has important implications for current ethics research guidance and for child health and research interna-

tionally, particularly research aiming to address health inequalities. We would welcome comments and feedback relevant to this review, particularly regarding completed or ongoing studies which report the impact of different forms of consent on participant recruitment and study outcomes. Croatian could be heard in the corridors of the CGH's building, people could be seen talking in Croatian on their cell phones or skyping with their families over the Atlantic. Everyone at the CGH were invited to a photo presentation of Croatian towns and natural attractions. A Canadian PhD student even expressed an interest in learning this Slavic language.

But the working language was English, and some serious work has been done through this Canadian-Croatian partnership, formalized in 2007 as the Global Academic Partnership (GAP) program between University of Ottawa, Canada, and the University of Split, Croatia. The idea of GAP is to improve health care and

academic medicine at the partner universities, with a focus on health equity. To promote the evidence-based medicine and health care in Croatia, a Croatian branch of the Cochrane Collaboration was established, with support of the Italian Cochrane Center. The role of the Canadian side in this international endeavour is to provide training for core members of the Croatian branch, and to help them achieve the envisioned goals. These include introducing the Cochrane activities and products in other countries of South-East Europe, where evidence-based medicine is still not a widely accepted practice. Recent history of violent conflicts in this region resulted in additional health inequalities that need to be addressed, and the Croatian Cochrane Branch plans to work on this problem,

together with their international partners and local stakeholders.

So, it seems that Croatian is to be heard in Ottawa's CGH for some time in the future. With regard to global health and academic medicine, there are still many

gaps. The GAP program will continue working to overcome them.

# Announcing Developments in the formation of the proposed Cochrane Justice Health Field

A diverse team of dedicated professionals, led by Dr. Catherine Gallagher have been working diligently to develop the Cochrane Justice Health Field (CJHF). CJHF aims to merge the methodological rigor and dissemination values of Cochrane with the complex research on health issues that uniquely or disproportionately impact justice populations and justice systems. Justice health can best be conceived as targeting high risk adolescent and adult populations served in justice settings, such as prisons, jails, detention centers, and community-based programs. Justice health also involves families of justice-involved individuals within a collateral consequence context.

Justice health highlights the needs of under-resourced and undereducated racial and ethnic minorities entangled in the control of justice systems around the world. This same demographic also suffers from a host of

social, physical, and mental health problems. Yet, the health services available for these populations are often substandard and inadequate, presenting a common challenge to human rights concerns and issues of health equity (The Lloyd Society, 2009).

As a developing health equity field, the CJHF team is perfectly poised to integrate systematic reviews to build the evidence base concerning justice health populations. Thus far, the CJHF team has:

1. Held exploratory meetings in Orlando, Florida (May 2009), Oslo, Norway (June 2009), and Singapore (October 2009). Dr. Gallagher and Dr. Kinner also presented on sexually transmitted diseases among justice health populations at the annual Colloquium in Singapore and met with several delegates to discuss the possible CJHF.

2. Submitted an application for a Justice Health

Field and await a response in the next couple of months.

3. Submitted a protocol for the first justice health review to an international Review Advisory Group concerning the protocol for the first Justice Health review.

4. Built 20 health equity libraries about disease prevalence among justice-involved populations.

In planning for the future, the team working to develop the Cochrane Justice Health Field will hold an organizational meeting on June 26th, prior to the 2010 International Network for Justice Health (INJH) Conference in Scottsdale, Arizona. In addition to developing and introducing the Justice Health Field, the CJHF is also looking forward to developing relationships and collaborating with our Health Equity colleagues.

The Equity-Oriented Toolkit is based on a needs-based model of health technology assessment.
